

RESOLUTION NO. 2023-26

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEBRING, FLORIDA, AUTHORIZING A BUDGET AMENDMENT TO THE ADOPTED FY 2023/2024 BUDGET.

WHEREAS, Florida Statute 216.011 defines an APPROPRIATION AS “a legal authorization to make expenditure”, then, no authorizations exist to exceed appropriated line item amounts in the budget. Should any cost requirements bring about a need for more funds than provided in a budget line item, no expenditure may be made until there is an authorized and approved budget amendment to provide more available fund, as set forth in the provisions herein.

WHEREAS, the City of Sebring will use General Fund Balance Brought Forward in the amount \$2,408;

WHEREAS, the City of Sebring will use these funds for the purpose of matching grant funds to purchase decontamination equipment for the Fire Department;

NOW THEREFORE, BE IT RESOLVED by the City Council of Sebring, Florida this 17<sup>th</sup> day of October 2023, that Budget Amendment #6 is hereby approved and authorized.
