A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEBRING, FLORIDA, AUTHORIZING A BUDGET AMENDMENT TO THE ADOPTED FY 2024/2025 BUDGET.

**WHEREAS**, Florida Statute 216.011 defines an APPROPRIATION AS “a legal authorization to make expenditure”, then, no authorizations exist to exceed appropriated line item amounts in the budget. Should any cost requirements bring about a need for more funds than provided in a budget line item, no expenditure may be made until there is an authorized and approved budget amendment to provide more available funds, as set forth in the provisions herein.

**WHEREAS**, the City of Sebring was awarded a grant from the Florida Department of Management Services with a value of \$310,000.00;

**WHEREAS**, the City of Sebring will use General Fund Balance Brought Forward in the amount \$140,868;

**WHEREAS**, the City of Sebring will use these funds for the purchase of 44 portable radios for the police department;

**NOW THEREFORE, BE IT RESOLVED** by the City Council of Sebring, Florida this 5<sup>th</sup> day of August 2025, that Budget Amendment #136 is hereby approved and authorized.
